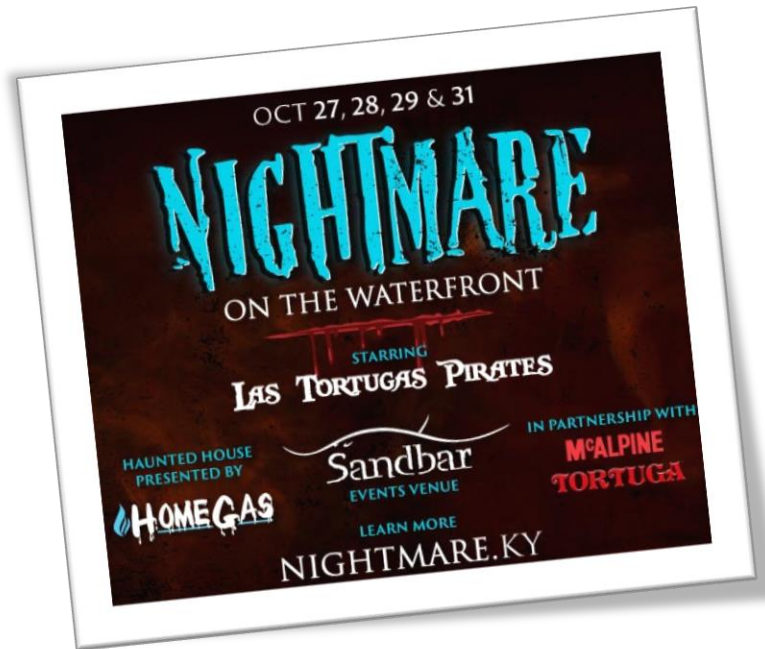

- c. from any advertisement or other publication prepared by Sponsor, including without limitation, any claims or liabilities for libel, slander, illegal or unfair competition or trade practices; infringement of trademarks, trade names or logos of third parties or the Organiser; violations of rights of privacy, publicity, infringements of copyrights of music performance rights and/or other proprietary rights; or advertisements which are otherwise contrary to law.

**4. Renewal**

- a. The Organiser agrees to give Sponsor priority to renew this agreement for the subsequent Event after the expiry of Agreement in 2022.

**5. Interpretation**

- a. Agreement will be interpreted according to the laws of the Cayman Islands
